### HISTORY AND GEOGRAPHICAL LOCATION OF THE UNIT

The HDEA research unit was formed in 2006 from the merger of three previous units (CATI – Cultures Anglophones et Technologies de l'Information, CEUMA – Centre d'Études Urbaines dans le Monde Anglophone, and Westpac – (Ouest américain/Asie pacifique) as recommended by the Mission Scientifique, Technique et Pédagogique (before AERES and HCERES). It is based at Paris-Sorbonne University and its premises are located at la Maison de la Recherche, 28, rue Serpente, 75006 Paris.

### SCIENTIFIC DOMAIN

The HDEA (Histoire et dynamique des espaces anglophones, du réel au virtuel) research unit is composed of civilisationists based in the English studies department at Paris-Sorbonne University. Its specialties until 2017 were the study of British and American society and culture as represented in visual media and new technologies (in the team CSTI-Cultures, *Sociétés et Technologies de l'Information*), environment, politics, religion, and the city in Anglophone countries from the 16th to the 21st centuries (MAPS – *Monde anglophone : Politiques et société*), and work in Anglophone cultures and societies (TCS – *Travail, Culture, Société*). Its new specialties are: *Le capitalisme sur le terrain aux 20<sup>e</sup> et 21<sup>e</sup> siècles*; *Les transformations de la famille aux 20<sup>e</sup> et 21<sup>e</sup> siècles au Royaume-Uni*; *Questions religieuses*; and *Territoires, environnement, écologie*.

## GLOBAL ASSESSMENT OF THE UNIT

HDEA has focused on Anglophone civilisation from the 16th to the 21st centuries in the areas of visual media and new technologies, environment, politics, religion, the city, and work. Its members produce world-class scholarship published in renowned international journals and encyclopaedias and by top-rated presses, and travel widely and frequently across France and abroad to give papers at globally-significant conferences, seminars, and workshops. Members also participate in the organisation of national and international educational and research initiatives. Furthermore, HDEA organises regular seminars and workshops and occasional conferences that attract world-class academics from France and abroad. HDEA has thus successfully followed the advice of the previous evaluation to build its national and international outreach. The unit has also successfully implemented AERES advice to synthesise its teams and synergise members' expertise through new strategies of managerial and budgetary rationalisation, and has maintained a mostly stable membership and near gender parity. More synergies might be created and to that effect its recent replacement of independent teams with research programmes under a single HDEA team is to be commended. The committee was impressed with the very positive attitude of members to the transparent, democratic, and responsive current leadership of the unit.

However, the committee has some concerns about the coherence of some axes within those programmes, and the unit badly needs institutional assistance with websites and other administrative matters. Specifically, the unit needs more secretarial assistance. It is to be noted that the Head and Deputy Head of the unit currently have no relief from teaching responsibilities. The unit is also in need of more workspace for hosting events with visiting speakers and for the purpose of asserting its presence and identity. PhD students also need a space to enhance their sense of connection to the unit and the university, and also require more administrative support and more direct involvement in the unit's activities. Despite these difficulties, the unit is very well-managed, produces first-rate scholarship and events, and deserves the national and international renown it achieves.
